Update on Stonehouse Farm (SF) – Clir Mercer

Cllr Mercer updated the PC on the current situation and outstanding Enforcement Orders on Stonehouse Farm.

DC/21/1050 Spinningwood Farm, Burnthouse Lane, Lower Beeding, West Sussex RH13 6NN.

Erection of light industrial building (Class E) and replacement of existing steel panel roof on existing light industrial unit with clay tiles.

Mr Kevin Woolgar (the applicant) of Hippo Golf Ltd attended the meeting and went over the application and his intent on the application.

The Parish Council had no major objections to this application however the following comments were made:

1/ The PC were in general against industrial developments in agricultural areas.

2/ The proposed site is outside of the BUAB.

3/ This proposal was not included in the LB Neighbourhood Plan.

4/ The applicant attended the meeting and agreed to limit the use of the site by condition.

The PC voted to remain Neutral on this application.

DC/21/1263 Twenty Five Acres, Leechpond Hill, Lower Beeding West Sussex RH13 6NR

Construction of equestrian rehabilitation and training centre comprising stable building and indoor sand school with internal facilities. Alterations to vehicle access and creation of new access road and car parking.

The Parish Council unanimously objected to this Planning Application on the following grounds:

The proposed site is / will

- 1/ Outside of the BUAB.
- 2/ Not included in the Neighbourhood Plan.

3/ Increase vehicle movements on an already very busy road.

4/ Within an AONB and a dark sky area.

5/ Without any accommodation on site for staff.

6/ An industrial enterprise in an agricultural area.

7/ Without water and other

utilities connected to the site.

8/ Is not sustainable and the application is not complete as the additional services needed to operate were not considered

The PC voted unanimously against this application.
