- HDC have been encouraging families to take in refugees, which has been very successful.

- PRoW issue at South Lodge There has been a breach of the Public Rights of Way (PRoW) path from the Brighton Rd to Jobs Castle. There is a planned extension to the vineyard in the South Lodge Hotel which will cover the existing PRoW. The Clerk has reported the infringement to the PRoW department.
