101/23 Report from District Councillor.

Cllr Livingstone reported the following:

- The current major HDC issue is the completion of the Local Plan. Until this is finalised every Parish is open to speculative development. Currently the Water Neutrality issue is the only thing holding these speculative planning applications in check.
- Following a meeting on the current planning application on the car park at Leonardslee Gardens. The application will be going to Planning Committee (North) on 4th July. The proposal must be considered as a new application not retrospective.
- He had a meeting regarding the issues surrounding Stonehouse Farm and reported that the owner
 has stepped back from the business and his son will now be the focal point for all enquiries. It was
 suggested that a joint meeting may be possible with Planning Officers, Parish and District
 councillors. The officers agreed to investigate the setting up of an on-site meeting.
- He gave an update on the current situation on Cisswood House Hotel. The hotel is now fully occupied. A discussion ensued regarding the hotel and the noise issues reported by local residents.
