061/19: Apologies for absence: Received from Cllr Ward Apologies were not received from Cllr Tabor

062/19: Approval of the minutes from the Parish Council meeting held on 26th March 2019. **The minutes were approved and seconded.**

063/19: Declaration of Interests from members in respect to any items on the agenda.

064/19: Report from District Councillor – Cllr Toni Bradnum

Cllr Bradnum stated that there was nothing to report due to the pending elections on 2nd May

066/19 Public Adjournment

The Vice-Chairman asked for a Public Adjournment

- Mr Fielding reported that some manhole covers had been taken or stolen on the Brighton Road which will be hazardous to all vehicles. The Clerk to report this to WS Highways immediately.
- There was a question from the public regarding the Neighbourhood Plan which the clerk informed the audience of the current progress of the plan.
- The Clerk reported the up-to-date information on the Community Speed Watch (CSW). Once again volunteers are sought after to keep the number of CSW sessions up to an active level.

067/19 Parish maintenance update - Cllr Lloyd

- Cllr Lloyd gave an overview on the current status of the kerbside cleaning contract undertaken by Mr Gevin White.
- Many of the PC voiced their concern on the lack of a paper trail, contract nor proof of public liability insurance and WS Highways authority
- The work carried out thus far was of a high quality however the PC asked for the documentation as requested before a payment can be made.
- There were several concerns voiced on the fact that the project went ahead without a contract.
- Cllr Lloyd put forward a motion that we will not undertake any further contracts without ensuring that all the correct contracts, Scope of Works, Hazard Assessment, Insurance documents were in place before the contractor was allowed to proceed. The resolution was passed by all Councillors.

069/19 Neighbourhood Plan (NP) update - Cllr Bamford

 Cllr Bamford gave an update of the position of the NP. With planned exhibitions, referendums later in the year targeted in late summer.

076/19 Planning

DC/19/0704 1 Crabtree Cottages Brighton Road Lower Beeding Horsham West Sussex RH13 6NH. Demolition of existing open pergola and erection of an enclosed link with roof lights between existing house and conservatory.

There was no objection from the Parish Council.

DC/19/0761 Church Lane Estate The Pole Barn Church Lane Plummers Plain RH13 6LU.

Retention of single storey extension to rear elevation.

The Parish Council **objected** to this application on the grounds that the extension has already been completed and the application was submitted retro-actively or *ex-post facto* (After the fact).

DC/19/0647 First Choice Services Ltd Church Lane Estate Church Lane Plummers Plain RH13 6LU Replacement of existing industrial buildings (Buildings C and D)

The Parish Council **objected** to this application on the grounds of very poor access to the site via either Church Lane or Winterpit Lane. The Lane is unsafe to use during working hours due to the volume of traffic. Although the PC is supportive of local business it was voiced that the access must be sorted out.

One member of the public who lives adjacent in the Church Lane Estate in Garwyn's Farm voiced his concern on the suitability of the access especially as the plans for development show larger buildings to replace the existing buildings.

DC/17/ 2086 Kennels and Rehoming center, Hammerpond Rd, Plummers Plain

Retention of existing kennels and re-homing center

This application is going to committee for assessment.

The PC has no objection except a restriction on the number of animals kept in the kennels.
