1/ This nursery already has two large signs erected at the front that are not in keeping with the village. We do

not approved of two more such signs as the two already in place are quite sufficient.

- 2/ The signs are too large, obtrusive and far too prominent. They are like advertising hoardings.
- 3/ They could impede the view of vehicles leaving the very busy junction of Church Lane and Handcross Rd.

4/ They are not in keeping with the local rural environment.
