## 057/25 Report from District Councillor.

Cllr Livingstone reported the following:

**Sustainability in action** – HDC have introduced new air quality monitors and are transitioning council fleets to electric vehicles. HDC now proudly holds the highest recycling rate in West Sussex.

Biodiversity is thriving, the Wilder Horsham initiative, and significant improvements at Chesworth, Owlbeech, and Warnham, including a stunning new viewing platform.

**Homes and Affordability** - In partnership with Saxon Weald, new affordable homes have been delivered, with key renovations preventing the loss of social housing.

More temporary emergency accommodation has been secured, and Horsham is probably the only council in Sussex offering 100% Council Tax Relief to its most vulnerable residents.

More social rental homes allowing local people to stay in the area by supporting Saxon Weald to build eight new, much needed, homes using Section 106 money from developers.

**Community and Connection** - HDC is funding free panto performances for disadvantaged and the vulnerable, a £100k People's Budget for youth, and enhanced public engagement at council meetings.
